TERMS OF USE

AGREEMENT TO TERMS

These Terms of Use constitute a legally binding agreement made between you, whether personally or on behalf of an entity ("you") and www.flowerbulbs-online.com (the Shop) ("Company", "we", "us", or "our"), concerning your access to and use of the <http://www.flowerbulbs-online.com> web-shop as well as any other media form, mobile web-shop or mobile application related, linked, or otherwise connected thereto (collectively, the "Site"). You agree that by accessing the Site, you have read, understood, and agreed to be bound by all of these Terms of Use. IF YOU DO NOT AGREE WITH ALL OF THESE TERMS OF USE, THEN YOU ARE EXPRESSLY PROHIBITED FROM USING THE SITE AND YOU MUST DISCONTINUE USE IMMEDIATELY.

Supplemental terms and conditions or documents that may be posted on the Site from time to time are hereby expressly incorporated herein by reference. We reserve the right, in our sole discretion, to make changes or modifications to these Terms of Use at any time and for any reason. We will alert you about any changes by updating the "Last updated" date of these Terms of Use, and you waive any right to receive specific notice of each such change. PURCHASES AND PAYMENT

We accept the following forms of payment:

You agree to provide current, complete, and accurate purchase and account information for all purchases made via the Site. Sales tax will be added to the price of purchases as deemed required by us. We may change prices at any time. All payments shall be made in U.S. dollars.

You agree to pay all charges at the prices then in effect for your purchases and any applicable shipping fees, and you authorize us to charge your chosen payment provider for any such amounts upon placing your order. We reserve the right to refuse any order placed through the Site. We may, in our sole discretion, limit or cancel quantities purchased per person, per household, or per order. ORDER CHANGES AND CANCELLATIONS

We must receive the cancellation of any order at least 4 weeks prior to the shipping date from the Netherlands. A cancellation fee of 50% of the order total will be applied. An order cancellation received by us within less than 4 weeks before the shipping date will not be accepted. In that case the order will be processed, shipped and delivered as per the initial order.

RETURN POLICY

Due to the nature of our product we do not offer a right to return an order once it has been delivered to the customer. For this we refer to art.10, pt. 8 of the 2014 "Thuiswinkel.org" terms and regulations.

PROHIBITED ACTIVITIES

Informal Negotiations
