General agreements Taalleermethoden.nl Workshops

Article 1. Registration for workshops

- 1. You can only register at our website or by filling in a registration form.
- Registration is official after reception of the completely filled in and signed registration form or after registration at our webshop.
- Incomplete forms and forms that are not signed will not be processed.
- 4. Registrations will be processed in order of entry.
- 5. Workshops will only take place in case of sufficient participants.
- 6. Registration is no garantee for placement.

Article 2. Placement

- 1. Everyone who can be placed will receive a written (digital) invitation or invitation by telephone for the workshop. This invitation is in the meantime a confirmation of placement.
- 2. After the invitation/confirmation you are obliged to pay the amount as mentioned at our website or at your invoice.
- Entry to the workshop is only possible after payment of the required amount.
 Everyone who can not be placed will receive a message; if possible a new date for another workshop will be arranged.

Article 3. Cancelation/termination before the end of hte workshop(series)

- 1. You always have to cancel in (digital) written form.
- 2. Cancelation is only without costs before the reception of your invitation for the workshop. Cancelation after the reception of your invitation to the workshop means you have to pay the entire amount.
- 3. In rare cases you'll be paid back in case of cancelation. You need to provide documents of evidence. In these rare cases you are obliged to pay € 25,00 administrative costs.

Article 4. Failure

1. Taalleermethoden.nl will take care that you can follow a workshop anyhow. In case where replacement of a workshopdate might not be possible, the money paid will be restituted.

Article 5. Prices

Article 6. Payment attendance
