## Terms & Conditions

No part of this site may be used by third parties without the consent of HOUSE-Dressing.nl. Pictures are the property of HOUSE-Dressing.nl and may not be used without permission or copied.

### 1. General

1.1 These terms and conditions apply to all offers of HOUSE-Dressing.nl. The conditions are accessible to everyone and included on the website of HOUSE-Dressing.nl. On request we send you a written copy.

1.2 By placing an order you acknowledge that you agree with the delivery and payment terms. HOUSE-Dressing.nl reserves the right to change its delivery and / or conditions after the expiry of the term.

1.3 Unless otherwise agreed in writing, the general or specific conditions or stipulations of third parties are not recognized by HOUSE-Dressing.nl.

1.4 HOUSE-Dressing.nl guarantees that the product meets the contract and meets the specifications listed in the offer.

1.5 Placed orders can only be canceled within 48 hours.

### 2. Delivery

2.1 Delivery takes place while stocks last.

2.2 HOUSE-Dressing.nl will orders within 30 days Under the rules of distance selling. If this is not possible because the ordered is out of stock or no longer available, or for other reasons delay, or an order can not or only partially implemented, consumers will receive within 1 month after placement of the order and has he in that case the right to cancel the order without penalty.

2.3 The supply obligation HOUSE-Dressing.nl, subject to proof, are satisfied once the once offered to the customer goods delivered by HOUSE-Dressing.nl. For home delivery extends the report of the carrier, alleging refusal of acceptance, the full proof of the offer to deliver.

2.4 All on the website are indicative. At the time limits may not be legally binding the half.

### 3. Prices

3.1 Prices will not be increased within the duration of the offer, unless legal action is necessary or if the manufacturer interim price policies.

3.2 All prices on the site are subject to misprints. For the consequences of misprints no liability is accepted.

3.3 All prices on the site are in euros and including 21% VAT.

3.4 Price changes may occur. You can find the latest prices always HOUSE-Dressing.nl. For the impact of printing and typographical errors, we assume no liability.

### 4. Term View / right of withdrawal

4.1 If there is a consumer purchase, under the Act on Distance (Article 7: 5 BW), the buyer has the right (a part of) the delivered goods within a period of 7 days without giving a reason. This period begins when the ordered goods are delivered. If the customer after this period the goods delivered has not returned to HOUSE-Dressing.nl, the purchase is a fact. The customer is obliged, before proceeding to return accordingly within the period of 7 days after delivery of written notice to HOUSE-Dressing.nl The customer must prove that the goods are returned on time, for example by means of a proof of mail delivery. Return of Goods must be in original packaging (including accessories and documentation) and in new condition. If the goods have been used, encumbered or damaged in any way, the right to terminate under this paragraph. Taking into account the not stipulated in the preceding sentence, HOUSE-Dressing.nl shall ensure that within 30 days after reception of the return, the full purchase price plus the shipping costs will be refunded to the buyer. The return of the delivered goods is entirely at the expense and risk of the buyer.

4.2 The right of rescission, as described in the preceding paragraph relates only to the goods delivered.

4.3 The right of withdrawal does not apply to:

- services where performance, with the consent of the consumer, is running for the period of seven days
- goods or services whose price depends on fluctuations in the financial market, which the supplier has no influence
- goods made to order
- goods which are manufactured according to specifications of the consumer, such as custom, or a clearly personal character
- for goods or services that can not be returned because of their nature, for example for hygiene or spoil or age quickly
- sale / discounted items

4.4 All goods are usually available from stock. However, it may happen that an item is temporarily out of stock. In that case you will get it, usually within a week (unless otherwise stated on the homepage of HOUSE-Dressing.nl) message and keeps HOUSE-Dressing.nl your order. If backorder no longer possible, you will be notified and will void your order. All mentioned delivery times are indicative only and do not lead to any right or liability.

### 5. Data

5.1 If you place an order with HOUSE-Dressing.nl, your data will be included in the customer base of HOUSE-Dressing.nl. HOUSE-Dressing.nl adheres to the Data Protection Act and will not provide your information to third parties.

5.2 HOUSE-Dressing.nl respects the privacy of the users of the website and ensures confidentiality of your personal information.

### 6. Warranty

6.1 HOUSE-Dressing.nl guarantees that the delivered products meet the requirements of usability, reliability and durability as intended by the parties to the contract reasonably, and therefore is responsible for the manufacturer of the product delivered to you.

6.2 The warranty HOUSE-Dressing.nl corresponds to the manufacturer's warranty period. HOUSE-Dressing.nl is never responsible for the ultimate suitability of cases for each individual application by the customer, nor for any advice regarding the use or application of the business.

6.3 The customer is obliged to immediately inspect the goods upon receipt. Should the goods delivered wrong, inadequate or incomplete, then the customer (before proceeding to return to HOUSE-Dressing.nl) to report these defects immediately in writing to HOUSE-Dressing.nl. Any defects or faulty goods should and can look up to one week after delivery to HOUSE-Dressing.nl be reported in writing. Return of Goods must be in original packaging (including accessories and documentation) and in new condition. Commissioning after detection of failure, damage occurring after detection of failure, encumbrance and / or resale after detection of failure, does the right to claim and return void.

6.4 If the customer complaints are found justified by HOUSE-Dressing.nl, HOUSE-Dressing.nl at its option or the goods delivered free of charge or replaced with the client a written scheme of compensation, provided that the liability of HOUSE-Dressing.nl and therefore the amount of compensation will be limited to no more than the invoice amount of the relevant property, or (at the option of HOUSE-Dressing.nl) to the maximum in the case concerned the liability of HOUSE-Dressing. namely amount covered. Any liability of HOUSE-Dressing.nl for any other form of damage is excluded, including additional compensation in any form whatsoever, compensation for

indirect or consequential damages or damages for lost profits.

6.5 This warranty does not apply if: A) as long as the purchaser against HOUSE-Dressing.nl is in default; B) the customer has parried the delivered goods themselves and / or processed by third parties to repair and / or edit. C) the delivered goods have been exposed to abnormal circumstances, or otherwise careless handling or contrary to the instructions of HOUSE-Dressing.nl and / or instructions on the packaging; D) were defective in whole or in part the result of regulations that the government has made or will make regarding the nature or quality of the materials used.

In the following cases, you can not claim the warranty:

- If there are changes or made to the article (whether for repair) by third parties;
- When exposed to moisture, (extreme) heat, cold or drought;
- If the date changes on the delivery or is illegible;
- If defects are caused by not having the corresponding destination or improper use (such as not proceed according to its instructions);
- In case of damage by intent or gross negligence;
- When external calamities (such as lightning, power outages, natural disasters, etc.);
- If you HOUSE-Dressing.nl does not take place, opportunity or time displays for research and restoration of the defect;
- If you fail and do not meet your obligations.

## 7. Offers

7.1 Offers are not binding unless otherwise stated in the offer.

7.2 Upon acceptance of an offer by the buyer, HOUSE-Dressing.nl the right to the offer within 3 working days of receipt of such acceptance to revoke or to deviate.

7.3 Verbal agreements HOUSE-Dressing.nl only after an explicit and confirmed in writing.

7.4 Offers of HOUSE-Dressing.nl not automatically apply to reorders.

7.5 HOUSE-Dressing.nl can not be held to its offer if the customer should have understood that the offer or any part thereof, an obvious mistake or error.

7.6 Additions, modifications and / or further agreements are effective only if in writing.

## 8. Agreement

8.1 An agreement between HOUSE-Dressing.nl and a customer comes into being after an order by HOUSE-Dressing.nl feasibility is assessed.

8.2 HOUSE-Dressing.nl reserves the right, without giving any reason not to accept orders or contracts or only to accept the condition that the shipment takes place after payment in advance.

## 9. Images and specifications

9.1 All images; photographs, drawings, etc .; eg data concerning weight, dimensions, colors, graphics, labels, etc. on the website of HOUSE-Dressing.nl only approximate, are indicative and may not lead to damages or rescission of the contract.

## 10. Force Majeure

10.1 HOUSE-Dressing.nl is not liable if and when she can not be fulfilled due to force majeure.

10.2 Force majeure means any strange reason, as also any circumstance, which she can not reasonably be held responsible for her. Delay or failure by our suppliers, disruptions in the Internet, disruptions in the electricity failures in e-mail traffic and disturbances or changes in any third party technology, transport problems, strikes, government measures, supply delay, negligence by suppliers and / or manufacturers of HOUSE-Dressing.nl co from individuals, disease, defects in appliance or shipment tools count explicitly as force majeure.

10.3 HOUSE-Dressing.nl reserves in case of force majeure to suspend the right to its obligations and is also entitled to terminate the contract in whole or in part, or to claim that the content of the agreement is amended so as to enable performance . In no event HOUSE-Dressing.nl is obliged to pay any penalty or damages.

10.4 If HOUSE-Dressing.nl at the time the force majeure has partly complied with its obligations, or can only partially fulfill its obligations it shall be entitled already delivered or the delivery part separately billing and the customer is obliged this invoice as if it were a separate contract. This does not apply if the delivered or deliverable part has no independent value.

## 11. Liability

11.1 HOUSE-Dressing.nl is not liable for damage to vehicles or other property caused by improper use of the products. Before use, read the instructions on the packaging and / or consult our website.

## 12. Payment

12.1 You pay in advance

After you have placed an order through HOUSE-Dressing.nl you automatically receive an order confirmation by email. If the total amount of the order is credited to the bank account of us, your order will be processed. Sent an order, it will notify you. With your order's billing of HOUSE-Dressing.nl.

12.2 Payment Orders

Payment orders for the bank and settings are at the expense and risk of the person who commissioned (or authorization) provides for payment.

12.3 The price

12.4 Contribution shipping

## 13. Applicable law / jurisdiction

13.1 All agreements are subject to Dutch law.

13.2 Disputes arising from an agreement between HOUSE-Dressing.nl and copper, which can not be resolved by mutual agreement, the competent court within the district Zaandam knowledge unless HOUSE-Dressing.nl prefer indicates the difference the competent court of the place of residence of the purchaser, and with the exception of those disputes that fall under the jurisdiction of a magistrate.
