Terms And Conditions

Article 1- Definitions

- 1.1 Of all the products on the site of by-sas.nl is only one piece in stock, which means that the consumer always carries a unique jewel.
- 1.2 Prices include VAT and exclusive shipping.
- 1.3 Secure payment options.
- 1.4 carefully packed in shipping
- 1.5 The consumer always has 14 days to return.
- 1.6 Not good money back

Article 3 Toepasselijkheid

- 3.1 all offers, orders and agreements by-sas.nl these Terms and Conditions apply.
- 3.2 Accepting an offer or placing an order means that you accept the applicability of these Conditions
- 3.3 The provisions can be done in writing in these conditions, in which case the remaining provisions shall remain in force.
- 3.4 All rights and claims, as in these conditions and any further agreements for by-sas.nl be made, are also stipulated for by by-sas.nl intermediaries and other third parties.

Article 4 Supply

- 4.1 All products containing by-sas.nl offering a complete and accurate description. The photos on the site are made by by-sas.nl himself and a true representation of the product. Obvious mistakes or errors in the offer do not bind by-sas.nl.
- 4.2 All products offers are unique, ie all products only 1 piece is available by-sas.nl. If there are unexpected by program fault 2 consumers simultaneously buy the same product, the first paying customer will receive the product and will by-sas.nl with the second consumer reach an appropriate solution.

Article 5 The agreement

- 5.1 An agreement is only after acceptance of your order by by-sas.nl. by-sas.nl is entitled to refuse orders or attach certain conditions to the delivery, unless otherwise specified. If an order is not accepted, by-sas.nl inform you within 3 working days after receiving the order.

Article 6 Right of withdrawal

- 6.1 The consumer may rescind the contract regarding the purchase of a product over a period of 14 days. The period begins on the day after the consumer or a third party designated in advance by the consumer other than the carrier has received the product.
- 6.2 During this period the consumer will treat the product and packaging.

Article 7 The price

- 7.1 The product prices include 21% VAT exclusive shipping.

Article 8 Payment

- 8.1 Payment must be made within 14 days after the invoice date, unless otherwise agreed in writing.
- 8.2 Payment can be made by Paypal, credit card, advance payment by bank transfer. For bank, the date of payment to the date of crediting the bank account of by-sas.nl.
- 8.3 If the consumer defaults on any payment, is entitled by-sas.nl (implement) the agreement and related agreements to suspend or dissolve.

Article 9- Delivery and implementation

- 9.1 By-sas.nl will exercise the greatest possible care when receiving and implementing orders for products and when assessing applications for services.
- 9.2 The products will be sent made known address within 2 to 3 working days to the consumer.
- 9.3 The delivery times specified by by-sas.nl are only indicative. Late delivery gives the consumer a right to compensation or the right to cancel the order or terminate the agreement, unless the delay in delivery is such that the consumer can not reasonably be required to maintain the agreement. The consumer is then entitled to cancel the order or terminate the agreement if necessary.
- 9.4 By-sas.nl shall not be liable for any delay, damage and / or loss of goods during shipment via PostNL.
- 9.5 The consumer gets from by-sas.nl always a Track & Trace code with which the shipment can be followed.
- 9.5 All products are made with care and inspected before being sent to consumers for damage and defects. Products to send to properly and securely packed!

Article 10- Return

- 10.1 The consumer has a period of 14 days to return the product commencing on the date of delivery under the following conditions:
- 10.2 The return should asap after receiving advance by e-mail to be notified. at by-sas.nl.
- 10.3 The returned items must explicitly unused, unworn and undamaged in original packaging, properly packaged and postage prepaid (if not sent by registered mail, we can not be held responsible for lost mail pieces!) To be returned, accompanied by (a copy of) invoice and return form.
- 10.4 The consumer will receive the purchase price and shipping costs. (After receipt of returned product).

10.5 The consumer will account for the cost of return. Not or insufficiently prepaid articles are not accepted by by-sas.nl, whatever the reason for the return.

10.6 In return already paid within 8 days refunded to the consumer.

10.7 After the consumer has to send the email with the return products, the consumer will receive an by-sas.nl return form via email.

WATCH OUT! If the consumer is not completed return form enclose in the return, the returned goods by-sas.nl can not process.

10.8 If the consumer received a wrong order, by-sas.nl will take care of sending the right items. By-sas.nl also reimbursed the shipping costs in full, unless the consumer has ordered a wrong product.

Exception: A product can not be returned if:

- Earrings for hygienic reasons.
- Products that are damaged, used or incomplete.
- The consumer has not sent an email for return.

Would welcome by-sas.nl the reason for return of the product, this is not mandatory, but by-sas.nl can learn from them again.
