

## **Consoleskins Privacy Policy**

Protecting your privacy is important to Consoleskins. We strive to keep your personal information confidential. By ensuring that you are aware of and understand the Consoleskins Customer Privacy Policy, we can provide you with better service. Please take a moment to read the following policy to learn how we handle your personal information.

### **Why We Collect Personal Information**

Consoleskins collects and uses your personal information to give you superior customer service, to provide you with convenient access to our products and services, and to make a wider range available to you. In addition, we use your personal information to keep you up to date on the latest service, special offers, and other information we think you'd like to hear about.

From time to time, we may also use your personal information to contact you in regards to keeping you updated of new Consoleskins products, artists, designs and special offers. If you no longer wish to receive these types of email communications you may opt-out at anytime. Please see the choice/opt-out section below.

If you purchase a product or service from us, we request certain personally identifiable information from you on our order form. You must provide contact information (such as name, email, and shipping address) and financial information (such as credit card number, expiration date).

We use this information for billing purposes and to fill your orders. If we have trouble processing an order, we will use this information to contact you.

### **How We Collect Personal Information**

We collect information about you in several ways. For example, we might ask for your contact information when you correspond with us, call us to make a purchase or request service, or participate in an online survey. In addition, when you complete your online order, we collect and store the information you provide in a secure database.

### **When We Disclose Personal Information**

Agents/Service Providers

We use other third parties such as a shipping company to fulfill orders, and a credit card processing company to bill you for goods and services, an email service provider to send out emails on our behalf and a third party marketing provider to provide broadcast email services for us.

These third parties are prohibited from using your personally identifiable information for promotional purposes. We reserve the right to disclose your personally

identifiable information as required by law and when we believe that disclosure is necessary to protect our rights and/or to comply with a judicial proceeding, court order, or legal process served on our Web site.

Consoleskins does not share, sell, rent, or trade PII with third parties other than as stated within this privacy policy.

### **Choice/Opt-out**

We provide you the opportunity to "opt-out" of having your personally identifiable information used for certain purposes, when we ask for this information. For example, if you purchase a product/service but do not wish to receive any additional marketing material from us, you can indicate your preference on our order form.

If you no longer wish to receive our newsletter and promotional communications, you may opt-out of receiving them by following the instructions included in each newsletter or communication or by emailing us at [info@consoleskins.nl](mailto:info@consoleskins.nl).

### **We protect your personal information**

Consoleskins safeguards the security of the data you send us with physical, electronic, and managerial procedures. We urge you to take every precaution to protect your personal data when you are on the Internet. Change your passwords often, use a combination of letters and numbers, and make sure you use a secure browser.

Consoleskins uses industry-standard Secure Sockets Layer (SSL) encryption on all web pages where personal information is required. To place on-line orders with Consoleskins, you must use an SSL-enabled browser such as Netscape Navigator 3.0 or later, or Internet Explorer. This protects the confidentiality of your personal and credit card information while it is transmitted over the Internet.

### **Data Retention**

We will retain your information for as long as your account is active or as needed to provide you services. Please contact us if you wish to cancel your account or request that we no longer use your information to provide you services. We will retain and use your information as necessary to comply with our legal obligations, resolve disputes, and enforce our agreements.

### **Cookies**

When you browse Consoleskins's website, you are able to do so anonymously. Generally, we don't collect personal information when you browse - not even your email address. Your browser, however, does automatically tell us the type of computer and operating system you are using.

Like many websites, the Consoleskins website uses cookie technology. When you first connect to our site, the cookie identifies your browser with a unique, random number. The cookies we use are not linked to any personal information about you. Cookies help us understand which parts of our websites are the most popular, where our visitors are going, and how long they spend there. We use cookies to study traffic

patterns on our site so we can make the site even better.

### **Third Party Cookies**

The use of cookies by third parties is not covered by our privacy policy. We do not have access or control over these cookies. These third parties use session ID cookies to make it easier for you to navigate our site, in order for you to use the shopping cart.

### **Social Media Features and Widgets**

Our web site includes social media features, such as the Facebook Like button and widgets, such as the ShareThis button or interactive mini-programs that run on our site. These features may collect your IP address, which page you are visiting on our site, and may set a cookie to enable the feature to function properly. Social media features and widgets are either hosted by a third party or hosted directly on our web site. Your interactions with these features are governed by the privacy policy of the company providing it.

### **Updating, Deleting or Correcting Personally Identifiable Information**

If your personally identifiable information changes, or if you no longer desire our service, you may correct, delete or update it by making the change on our member information page or by emailing our Customer Support at [info@Consoleskins.nl](mailto:info@Consoleskins.nl).

### **Our Companywide Commitment to Privacy**

To make sure your personal information remains confidential, we communicate these privacy guidelines to every Consoleskins employee. Consoleskins does not knowingly solicit personal information from children or send them requests for personal information.
