## Article 3 – Basis of the sale

1. The placing of an order by a customer shall constitute an offer to [www.gardentowereurope.eu](http://www.gardentowereurope.eu) to purchase one or more of its products at the current price as advertised by [www.gardentowereurope.eu](http://www.gardentowereurope.eu) and an acceptance of these terms and conditions.
2. [www.gardentowereurope.eu](http://www.gardentowereurope.eu) will confirm receipt of the customer's order electronically.
3. TPL BV reserves the right to refuse an order. In the event an order is not accepted then TPL BV will communicate this to the customer within 14 days of receipt of the order.

## Article 4 - Cancellation, return and refund

1. The customer has the right to cancel the agreement within 14 days of receiving the goods. The customer will receive a full refund after the products has been returned complete and undamaged to TPL BV. A cancellation form is available on the website.

## Article 5 – Prices

1. Prices are as advertised in the [www.gardentowereurope.eu](http://www.gardentowereurope.eu) webshop and they remain valid for any placed order. Price changes will be implemented as needed.
2. All prices are inclusive of Dutch VAT (21 %) and include shipment to the customer in The Netherlands, Belgium and Germany. Surcharges are imposed as needed for other countries and stated on the website.

3. All payment details are sent via SSL technology, which is also used by banks. SSL technology guarantees that personal details are protected and can never be seen or manipulated by unauthorized persons.
