Your privacy is of great importance for Flatsix Sportscar Collectables. We therefore comply with the privacy law. This means that your data is safe with us and that we always use it properly. In this privacy statement we explain what we do with the web store Flatsix-sportscar-collectables.nl with information that we learn about you..

Handling order

When you place an order with us, we use your personal data to handle it properly. We may then give your personal details to our delivery service to have the order delivered to you. We also receive information about your payment from your bank or credit card company.

For this we use your payment details, name and address, e-mail address and billing address. We are legally obliged to do this. We keep this information until your order has been completed and seven years after that (that is the legal storage obligation)

Statistics and profiling

We keep statistics on the use of our web store. With these statistics we improve our web shop to show only relevant information. We may combine your personal data to learn more about you. Of course we will respect your privacy at all times. If you do not want this, you can always report this to us.

For this we use your IP address. We have a legitimate interest in this. We keep this information for six weeks.

Contactform and Newsletter

With the contact form you can ask us questions or make requests.

For this we use your e-mail address, name and data and gender. We need this because of the contract we conclude with you. We keep this information until we are sure that you are satisfied with our response.

You can subscribe to our newsletter. Here you can read news, tips and information about our products and services. You can cancel this subscription at any time. Each newsletter contains an unsubscribe link.

Your e-mail address will only be added to the list of subscribers with your permission. This data is saved until you cancel the subscription

Advertisement

We would like to send you advertising about offers and new products or services. We do this:

- by email
- via social media

You can object to this advertisement at any time. Each e-mail contains an unsubscribe link. You can block us or use the unsubscribe option.

Provision to other companies or institutions

With the exception of the aforementioned partners, we do not, under any circumstances, provide your personal data to other companies or institutions, unless we are legally obliged to do so (for example if the police require this if there is a suspicion of a crime).

Social media buttons are included in our web store. The administrators of these services collect your personal data.

Cookies

Our webshop uses cookies. Cookies are small files where we can store information so that you do not have to enter it all the time. But we can also see that you are visiting us again

When you visit our webshop for the first time, we will display a notification with an explanation about cookies. Hereby we will ask for your agreement for the use of these cookies.

You can disable the placing of cookies via your browser, but some things from our webshop will not work properly anymore.

We have made agreements about the use of cookies with other companies that place cookies. However, we do not have complete control over what they themselves do with the cookies. Read their privacy statements.

Google Analytics

We use Google Analytics to keep track of how visitors use our web store. We have signed a processor agreement with Google. There are strict agreements about what they can keep up with. We have not allowed Google to use the obtained Analytics information for other Google services. We do not let Google anonymize the IP addresses.

Security

Security of personal data is of great importance to us. We ensure that your data is properly secured with us. We always adjust security and pay attention to what can go wrong..

Changes to this privacy statement

When our web store changes, we must of course also adjust the privacy statement. Always pay attention to the date above and check regularly for new versions. We will do our best to announce changes separately

Access, change and delete your data

If you have questions or want to know what personal information we have about you, you can always contact us. See the contact details below.

You have the following rights:

- Receive an explanation of what personal data we have and what we do with it
- Insight into the exact personal data we have
- To have errors corrected
- The removal of outdated personal data
- Withdrawing permission

To file a complaint
