CANCELLING

Right of Withdrawal

The customer has the right to cancel and revoke the contract within 30 calendar days without giving any reason

In order to exercise the Right of Withdrawal, the customer has to send the trader using the name and address below, a notification on a durable medium (e.g. in writing by mail or e-mail).

The customer can use the form, but is not obliged to do so. A customer exercising the Right of Withdrawal can not be charged with costs.

In addition to the Right of Withdrawal there may be customer rights under national contract law. (e.g. termination of the agreement if certain information was not provided).
